I heard nothing back until just recently when the participant sent me proof - the Certificate of Attendance. Her Certificate was only signed by the CMP Sponsor and not the presenter. In addition, she did not sign in on the RID Sign-In sheet. RID says the following:

The CMP Sponsor of this event respectfully reminds hosts, presenters, and attendees that attendance must be recorded on the Activity Report Form for CEUs to be awarded. The CMP Sponsor cannot accept requests to modify the attendance record after it has been received following the workshop. It is the responsibility of the host or presenter and each attendee to ensure that the names and member numbers provided on the Activity Report Form are an exact match to the member's information in the RID database.

CMP Sponsor's signature on a Certificate of Attendance does not verify or validate that the participant attended an event (i.e., workshop).

I am working with CFI (California Federation of Interpreters) on their 2016 conference in Los Angeles, to provide CEUs for the Sign Language Interpreters who will be attending.
