

# SCRID Membership Committee Report

November 2016

The Membership Committee reports:

- We have mailed out eleven (11) new member cards since mid-October, with additional renewals and new memberships currently being processed. All mailed cards/Members have been verified as “Active” and “Paid” in Wild Apricot. The remaining will be processed prior to the end of November 2016, and on-going.
- We are currently streamlining our method of double-checking and auditing the Wild Apricot Membership Database entries. We have assisted 2 members with complex needs this past month.
- Reminder - The “*Certified – Senior Citizen*” Membership Discounted Rate was passed at the May 2016 Meeting (05/14/16). (We have our first paid “Certified – Senior” Category Member!) The Discount has been added to the SCRID Membership Renewal Page – through Wild Apricot/PayPal. This Discounted Rate applies to Certified and Associate Member levels. We have fielded some questions from members concerning submission of “verification of age”. A valid CA Drivers License is adequate. - We emailed the general membership, reminding everyone to ensure that their SCRID and RID Categories coincided/agreed. Paying for Certified RID and Associate SCRID Memberships (or Associate RID and Certified SCRID) is disallowed under both organizations’ policies, as well as the NAD-RID CPC, and misrepresents professional and certification standing. Professionals with integrity will ensure that their Membership Categories match. The Membership Committee will be working with the SCRID Board and RID National Office to ensure fair and adequate time frames for members to amend/align their professional Membership Categories.
- The Membership Committee continues to audit our current membership, reconciling appropriately matching Membership Categories, Contact Information, and correctly identified Certification titles. An email reminder was sent out to all current, pending-new and pending-renewal members to ensure that SCRID and RID Membership Categories are the same.
