

CMP Monthly Report February 10, 2017

Overview:

This report will contain the activities from mid-January to mid-February.

Latest workings:

Workshop name entries – I received a call about a December workshop that a participant had not been added. The participant had signed in with a last name that did not match what was in the RID DB. This is a common occurrence. I also found out that the uploading of the other participants for this same workshop, didn't upload successfully. I had to get some assistance from Ashley Holliday (RID PDC) because I could not get the file to upload.

RID PDC (Carol Turner) sent me a list of workshops that had not been closed out for the calendar year 2016. This is the workshop I experienced an error in uploading (see above). Notified Carol Turner that the workshop is now closed.

Lori Bellama (from SDCRID Co-Mentorship Committee Chairperson) and I discussed what it would look like to use the IS for their mentor-mentee activity for earning CEUs. Their program has been down for a while and she wants to start back up. She was thinking of using the IS for each mentor so they can earn CEUs. Lori is thinking of having a small group to start with, 10 mentors (paired with 10 mentees). She hasn't decided how long the mentorship activity will be, e.g., 3 mos, 6 mos, one-year. She is researching this possibility and will meet with her Co-Membership Committee Chairperson to layout out this activity.

A presenter sent me her Instructor form to review. She wanted to make sure she understood what really is needed and wanted for the form. I did. And now I have informed her to send in all the documentation and payment for an official review.

One member keeps sending me their CMP documentation to my personal email address. I have not yet been able to convenience her it needs to be sent to the CMP email address. So, I have been forwarding them all to my CMP.

I updated the CMP webpages to reflect that only PC compatible documentation can be sent. This was in result of one presenter sending me everything with file extensions generated from MAC software. I was unable to open any of the documents.

A link Bloom's Taxonomy for the measurable verbs for the IS page was added. I noticed it was not there after talking with Lori from SDCRID.

A group of presenters wanted PS CEUs for their workshop, after I determined it warranted GS. The presenters sent in a good argument and I discussed this with RID, in addition, I provided why I left the content area was GS. RID supported my justifications.
