# CMP Monthly Report April 14, 2017

#### Overview:

This report will contain the activities from mid-March to mid-April.

## **Latest workings:**

I wrote up the Complimentary Benefit webpage, in Word. I sent it out to the SCRID leadership for their input.

With the help of Peggy, using WA, the averages and projections report was created to determine the financial impact of implementing the Complimentary Benefit. I have contacted other AC CMP Sponsors who offer free CEU processing to determine how they financially afford it. I am working with the Treasurer and Membership to try and get numbers to determine an estimate of financial impact on SCRID if this benefit is implemented. I wrote up the Financial Impact of the Complimentary Benefit and sent to President and Treasurer for thier review.

I created a new PINRA form which is only for pre-approved CIMCE courses for the LA Superior Court (LASC) Sign Language Interpreters who need RID CEUs. I am calling this form LASC PINRA to not confuse it with the standard/regular PINRA form. I have sent the form and instructions to Joan Wright, the LASC Court Training Manager, to share with the LASC interpreters. This LASC PINRA is designed to be active for one calendar year. Because of that, no other SCRID benefits can be applied to this PINRA.

I did not realize I was to check WA for any unpaid CMP requests. I found 4 requests that were unpaid and 1 paid but needed to be transferred. (2 IS, 2 PINRA, 1 workshop). Two were a registration cancellation, the other was transferred from IS to AC. On the last unpaid member, I have found she had 2 unpaid invoices. One was an IS transferred to PINRA which created a new invoice and labelled it unpaid. The Treasurer found the PayPal receipts for me (thank you). I then closed the 2 unpaid invoices. This member had a lot of PINRAs, therefore, I needed her assistance. I printed a query report for this member for all invoices form 2015-2018 and sent to her.
